Consulting Services Proposal For

Proposed Deer Creek Combined Cycle Energy Conversion Facility PUC Docket EL08-034

At the request of the Local Review Committee (LRC) established to assess the extent of the potential social and economic effects to be generated by the proposed Deer Creek Combined Cycle Energy Conversion Facility near White, SD, I offer the following proposal to assist the LRC in assessing not only the potential social and economic effects, but also the area's capacity to absorb the effects at various stages of construction and to formulate mitigation measures.

- 1. Pursuant to SDCL 49-41B-7 I will assist the Local Review Committee in determining the temporary and permanent alternatives in the following areas:
 - a. Housing Supplies
 - b. Educational Facilities and manpower
 - c. Waste supply and distribution
 - d. Waste water treatment and collection
 - e. Solid waste disposal and collection
 - f. Law enforcement
 - g. Transportation
 - h. Fire protection
 - i. Health
 - i. Recreation
 - k. Government
 - 1. Energy
- 2. In order to provide the necessary input, I will review the documents submitted by Basin Electric Power Cooperative in Docket #EL08-034 dated July 2009. I will formulate questions and concerns to be reviewed by the LRC.
- 3. I will, within the PUC defined "affected area" (twelve mile radius in South Dakota), contact local governmental agencies including County Commissions, Mayors, Chief Law Enforcement Officers, Fire Chiefs, and School Superintendents requesting their input on the positive and negative effects of the proposed project. It is expected that this will require meeting with or having phone conversations with approximately 30 separate agencies.

- 4. I will contact local Economic Development Agencies, Real Estate Professionals, home builders and apartment/rental property owners to assess the availability of short term and long term housing in the area. It is expected that this will require meeting with or having phone conversations with approximately 20 separate entities.
- 5. I will meet with the LRC as necessary to review information gathered, take feedback on the draft report and get approval of the Final Report. It is anticipated that this will require three (3) meetings with the first scheduled for November 5 to review progress.
- 6. Contact with members of the Local Review Committee will be primarily by email except for those scheduled meetings detailed above.
- 7. A Final Report will be provided for the LRC to forward to the PUC by January 15, 2010. This report will be provided in hard copy and in PDF (digital) form.

The cost of providing the above referenced services shall be \$10,500 excluding any applicable sales tax. It is anticipated that reimbursement will come from the Public Utility Commission and that this remuneration would not be subject to sales tax. The calculations for this fee are as follows:

1.	Project review	5 hrs
2.	Meetings with LRC	6 hrs
3.	Personal and telephone contacts	48 hrs
4.	Report writing	<u>38 hrs</u>
	Total labor hou	ırs 97 hrs

Indirect costs of printing, travel, supplies and miscellaneous are estimated at \$800. A total of 97 hours at \$100 per hour results in a labor cost of \$9,700 thereby generating a total cost of consultant services in the amount of \$10,500.
