Decommissioning Bond

KNOW ALL MEN BY THESE PRESENTS:

That we, **Basin Electric Power Cooperative** as Principal, and **Liberty Mutual Insurance Company**, as Surety, are held and firmly bound unto the **South Dakota Public Utilities Commission** in the full and just sum of Fifteen Million One Hundred Twelve Thousand Two Hundred Thirty Three (\$15, 112, 233.00) Dollars in lawful money of the United States of America, for which payment well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

The condition of this obligation is that the said Principal has agreed to furnish this bond as a condition precedent to the Stipulation of Financial Assurance as outlined in the Joint Motion for Approval of Decommissioning Plan and Stipulation of Financial Assurance dated October 12, 2021.

Now, Therefore, this bond shall comply with the provisions of SDCL 49-41B-39, and if said Principal shall comply with the provisions set forth in the Wind Project Decommissioning Plan, then this obligation shall be void; otherwise, to remain in full force and effect.

This bond shall be further subject to the following conditions:

1. The bond shall be continuous and shall remain in full force until the Surety is released from liability by the South Dakota Public Utilities Commission or until the bond is cancelled by the Surety as herein provided. This bond may be cancelled by Surety by giving ninety (90) days written notice to the Obligee by certified mail. Such cancellation shall not affect any liability the surety has incurred under this bond prior to the effective date of the termination.

2. Upon receipt of cancellation notice, Principal must provide a replacement security acceptable to Obligee as demonstrated through a Commission order approving the replacement security.

3. If principal does not provide a replacement security acceptable to Obligee, the Surety shall: (1) rescind the bond cancellation, or (2) promptly arrange for the decommissioning of the Project as required per the Wind Project Decommissioning Plan, or (3) pay the bond beneficiary and/or the assignee(s) of the beneficiary's interest for any out of pocket costs incurred to decommission the Project, minus salvage value.

4. In no event shall the total liability of the Surety for any one or more recoveries under this bond exceed in the aggregate the total sum hereof.

5. Any suit brought upon this bond must be instituted before the expiration of one years after the release, cancellation or termination hereof.


