The information contained within Exhibit _____(BDM-2), Schedule 2, meets the definition of "trade secret" under the SDCL §37-29-1(4)(1), the South Dakota Uniform Trade Secret Act, which is defined as information that "Derives independent economic value, actual or potential, from not being generally known to, and not being readily ascertainable by proper means by, other persons who can obtain economic value from its disclosure or use, and... Is the subject of efforts that are reasonable under the circumstances to maintain its secrecy."
- 5. Exhibit ____(BDM-2), Schedule 2, contains proprietary business information which OTP does not disclose to the public. This information would provide actual and potential competitors with information that could provide competitors with an unfair competitive advantage. Accordingly, OTP respectfully requests that the South Dakota Public Utilities Commission grant this request for confidential protection and treatment.
