The Order incorporated by reference the Settlement Stipulation executed by Principal and the Commission staff on June 6 and 7, 2011 ("Stipulation"). In accordance with the Stipulation and Order, in particular paragraph 7 of Section 3, Terms and Conditions of the Settlement Stipulation ("Conditions"), Principal has negotiated or will negotiate an agreement or agreements with, and has applied or will apply for a permit, permits, or permission to do work within and utilize the public right-of-way, roads, highways, bridges or other related facilities of, all such South Dakota townships, counties, and other governmental entities whose property is crossed by the transmission facilities described in the Stipulation and Order.

NOW, THEREFORE, the condition of this bond is such that is said Principal shall during the continuance of such permit, permits, or permission faithfully perform and comply with all of the provisions of the Stipulation dealing with public roads, highways, bridges, or other related facilities, particularly Conditions 7, 8, 10, and 27, and said agreements, permits, or permissions, then this obligation shall be null and void; otherwise it shall remain in full force and effect.

This Bond shall remain in effect until released by the Commission in accordance with Condition 27 of the Stipulation and shall not be cancelled by Surety prior to such time. Regardless of the amount of time that this bond remains in effect, in no event will the liability of the Surety exceed the sum stated above.
