Otter Tail Power Company ("Otter Tail") submits for South Dakota Public Utilities Commission ("Commission") approval, a revised Section 16.00, Sheet No. 3. This revised sheet is the third revision to Sheet No. 3 of Otter Tail's Summary of Contracts with Deviations.

The municipal service agreement between Otter Tail and the Town of New Effington, SD, listed on Otter Tail's current Summary of Contracts with Deviations, will expire on May 1, 2012. Otter Tail and the Town of New Effington entered into a new agreement for municipal services with an effective date of May 1, 2012. Under the new agreement, electric service provided by Otter Tail to the Town of New Effington is at Commission approved tariffed rates and therefore a contract with deviations no longer exists with the Town of New Effington.

Additionally the municipal service agreement between Otter Tail and the City of Oldham, SD, listed on Otter Tail's current Summary of Contracts with Deviations will expire on May 15, 2012. Otter Tail and the City of Oldham entered into a new agreement for municipal services with an effective date of May 15, 2012. Under the new agreement electric service provided by Otter Tail to the City of Oldham is at Commission approved tariffed rates and therefore a contract with deviations no longer exists with the City of Oldham.

The Town of New Effington and the City of Oldham have been removed from Otter Tail's Summary of Contracts with Deviations as shown on the attached Section 16.00, Third Revised Sheet No. 3 Cancelling Second Revised Sheet No. 3.

Pursuant to ARSD 20:10:13:26 Otter Tail submits Exhibit A as the South Dakota "Report of Tariff Schedule Change".
