## Transmission Cost Recovery Rider Rate Increase Effective May 1, 2014

Xcel Energy has upgraded transmission facilities to help ensure continued safe and reliable service to our South Dakota customers. The South Dakota Public Utilities Commission has approved a Transmission Cost Recovery (TCR) Rider as a separate line item on your monthly electric bill beginning May 1, 2014 to recover the cost of new and modified transmission facilities. The rate factor will increase from \$0.000000 per kWh to \$0.002868 per kWh.
