

# EXHIBIT A

## Legal Description of the Electric Service Territory Boundary between Kingsbury and H-D

Based on a prior agreement dated the 17th day of December, 1975, signed by Kingsbury Electric Cooperative, Inc. (Kingsbury) and H-D Electric Cooperative, Inc. (H-D), the following represents the legal description of the electric service territory boundary shared between Kingsbury and H-D.

BEGINNING at the SW corner of Government Lot 2 of Section 31 of Township 113 North (T113N), Range 55 West (R55W), Hamlin County,

THENCE continue east to the SE corner of the NE  $\frac{1}{4}$  of Section 32 of T113N, R55W,

THENCE continue south to the Hamlin/Kingsbury County line to the SW corner of Section 33 of T113N, R55W,

THENCE continue east along the Hamlin/Kingsbury County line to the SE corner of Section 35 of T113N, R55W,

THENCE continue north to the SW corner of the NW  $\frac{1}{4}$  of Section 36 of T113N, R55W,

THENCE continue east to the SE corner of the NE  $\frac{1}{4}$  of Section 36,

THENCE continue south to the Hamlin/Kingsbury County line to the SW corner of Section 31 of T113N, R54W,

THENCE continue east along the Hamlin/Kingsbury County line to the SE corner of the SW  $\frac{1}{4}$  of Section 33 of T113N, R54W,

THENCE continue north to the SW corner of the NE  $\frac{1}{4}$  of Section 33,

THENCE continue east to the SE corner of the NW  $\frac{1}{4}$  of Section 35 of T113N, R54W,

THENCE continue south to the Hamlin/Kingsbury County line to the SW corner of the SE  $\frac{1}{4}$  of Section 35,

THENCE continue east along the Hamlin/Kingsbury County line to the SE corner of Section 36 of T113N, R54W,

THENCE continue north to the NW corner of Government Lot 3 of Section 31 of T113N, R53W,

THENCE continue east to the NW corner of the SE  $\frac{1}{4}$  of Section 31,

THENCE continue south to the Hamlin/Kingsbury County line to the SW corner of the SE  
¼ of Section 31,

THENCE continue east along the Hamlin/Kingsbury County line to the SE corner of  
Section 32 of T113N, R53W,

THENCE continue north to the SW corner of the NW ¼ of Section 33 of T113N, R53W,

THENCE continue east to the SE corner of the NW ¼ of Section 33,

THENCE continue south to the Hamlin/Kingsbury County line to the SW corner of the SE  
¼ of Section 33,
