## AFFIDAVIT OF ALLAN DEWALD

Allan Dewald, being first duly sworn on oath, deposes and states:

- 1. On July 16, 2014, I received notice from Black Hills, Power, Inc. that the above-captioned 230 kV transmission line project would be located within one-half mile of the following described real property for which I am the owner of record: parcel 3611200001 (N½ NE¼, S11, T1N, R06E, Black Hills Meridian), and 361210004 (W½ NW¼ less Lot B of Dewald's Sub, SE¼ NW¼, S12, T1N, R06E, Black Hills Meridian).
- 2. In addition to the above-referenced parcel of property, I am the owner of record of real property with the following legal description: NW1/4 NE1/4 NW1/4; SE1/4 NE1/4 NW1/4; SW1/4 NW1/4 NE1/4 Less Lot A of Hillenbrand Sub; S1/2 NE ¼ Less Lot A of Hillenbrand Sub, and Dewald's Sub, Lot B. This parcel was not located within one-half mile of the original proposed site that was the subject of the July 16, 2014 notice.
- 3. Black Hills Power, Inc. has advised me that a South Dakota landowner whose property will be traversed by the Company's 230 kV transmission line project has requested a change in the route that was approved by the South Dakota Public Utilities Commission ("Commission") in its December 14, 2014 Final Decision and Order. A map depicting the route change that was presented to me is reflected in Attachment A hereto.
- 4. I am aware that if Black Hills Power chooses to pursue the proposed route, as the owner of record of an additional parcel of property that now falls within one-half mile of the project site, I was entitled to receive notice of the project in advance of a decision from the Commission pursuant to SDCL § 49-41B-5.2.

- 5. I hereby waive the right to notice that I, as the owner of record, was entitled to receive for this additional parcel under SDCL § 49-41B-5.2.
- 6. I have no objection to the proposed route that is set forth in Attachment A hereto and therefore consent to the route and support the Commission's approval of the same.
