Summary of sheets that have been updated for new information:

- Sheets 2, 4, 7, 10, 14, 17, 21, 22, 23, 24, 27, 32, 34, 37, 40, 44 Change the tariff pricing to reflect the roll out of the correct Energy Cost Adjustment factor of \$(0.00751).
- Sheet 62 changes Clause ECA – Energy Adjustment factor for all rates to \$(0.00751).

MidAmerican is also providing red-lined copies of the tariffs that had changes.

The purpose of this filing is to correct an inadvertent error discovered in the original base rate increase request filed August 4, 2014. As explained by Ms. Kutsunis in her supplemental testimony, in the original filing an error was made in the energy cost adjustment (ECA) factor calculation. The incorrect ECA factor was subsequently rolled out of base rates. With this filing, MidAmerican corrects the error and revises the tariff sheets accordingly.
