Dear Secretary Bose:

In Docket No. ER14-1757-000, ITC Midwest LLC (“ITC Midwest”) tendered for filing with the Federal Energy Regulatory Commission (“Commission”) the Third Amendment to and Restatement of the Facilities and Operating Agreement Ottumwa Generating Station Unit 1 Electric Transmission and Substation Facilities (“Facilities Agreement”) among ITC Midwest, MidAmerican Energy Company (“MidAmerican”), and Interstate Power and Light Company (“IPL”) (together, the “Parties”).

The original Ottumwa Generating Station Unit 1 Electric Transmission and Substation Facilities Agreement, between predecessors of MidAmerican and IPL was dated May 22, 1981, and amended January 1, 1997.

On January 18, 2007, IPL entered into an Asset Sale Agreement with ITC Midwest under which ITC Midwest purchased IPL’s transmission system assets.<sup>1</sup> As a result, MidAmerican, IPL and ITC Midwest entered into an Agreement Governing the Assignment of Transmission Contracts, dated December 20, 2007, whereby, among other things, certain of IPL’s transmission assets and associated rights, responsibilities and obligations under the Facilities Agreement were assigned to and assumed by ITC Midwest with the consent of MidAmerican, such that the Unit 1 Transmission Agreement is now a three-party agreement.

### **I. Description of Filing**

Third Amendment of and Restatement of Facilities and Operating Agreement – Electric Transmission and Substation Facilities for Ottumwa Generating Station Unit 1 (originally dated May 22, 1981, as amended January 1, 1997), effective June 24, 2014.

MidAmerican respectfully requests that the Commission make the Certificate of Concurrence effective as requested by ITC Midwest. To the extent that the Commission determines that any requirements of 18 C.F.R. § 35 apply that have not been specifically addressed herein, MidAmerican respectfully requests waiver of such requirements.
