PETITION OF OTTER TAIL POWER COMPANY

### I. OVERVIEW

Otter Tail Power Company ("OTP" or "Company") submits to the South Dakota Public Utilities Commission this Petition for approval of a Customer Meter Data Privacy Tariff as a new provision to the Company's Electric Rate Book. The purpose of this filing is to recognize the role the Company plays in protecting customer meter data in its possession and meeting our customers' expectations of privacy. The proposed tariffs follow industry standards and balance the need to protect customer privacy while allowing OTP to conduct regulated utility operations.

# II. REQUIRED INFORMATION

The following information is provided in accordance with South Dakota Administrative Rule 20:10:13:26, the tariff schedule change notification requirements.

#### (1) Name and Address of the Public Utility

### (3) Description of the Change

The proposed tariff sheets inform customers of how the Company maintains, uses and discloses customer energy usage data (a.k.a. meter data) in the ordinary course of business.

### (4) Reason for the Change

The purpose of this filing is to provide South Dakota customers information about how OTP collects, maintains and in some cases discloses customer energy usage (a.k.a. meter data) in the ordinary course of business. The proposed tariff makes clear that the energy usage data of retail customers is held in confidence by the Company subject to limited exceptions. While OTP has yet to install advanced metering infrastructure on a significant basis the tariff provides a framework that balances customer privacy concerns with the Company's need to conduct regulated utility operations. This framework has application to current metering systems as well as advanced metering infrastructure.

# (7) Proposed Effective Date of Modified Rate

OTP proposes that the Customer Meter Data Privacy Tariff be effective March 1, 2017.
