Hi Connie,

Thank you for talking the other day. As we discussed Geronimo's Crocker project is located near the town of Crocker South Dakota, while the wind farm is in Clark County our interconnection is located in Day County. Our plan to avoid

grassland easements was complicated when one of our landowners backed out of the project creating a block that prevented us from going north with our transmission line without impacting USFWS easements. Attached is a map showing the easements, our general project location, the land not available to us because of landowner issues and general location information. Notably, the project boundary is still under development though it is primarily going south as other directions take the project to lower elevations.

When we talked, you mentioned that some of these easements have exceptions in their exhibits that might pave the path to an interconnection of the project without involving the services interests. We are open to that idea and others that might allow for the project to avoid the Service's interests. We are also interested in continuing the conversation about going through the programmatic process to obtain a permit or consent for occupation of land that is under easement with the Service. Would the end of next week be sufficient time for us to have a productive follow up conversation on the routing of the line?
