Geronimo/Crocker Wind Farm,

Crocker Wind Farm representatives have had multiple coordination communications with personnel at Northern Border Pipeline Company over the past year to discuss the interaction of the project and their pipeline. The discussions have included confirmation that Northern Border will be able to continue pipeline flyovers through the project area, coordination around how construction activities will be monitored by Northern Border Pipeline during construction and coordination around the appropriate agreements and standards for wind farm facilities crossing the pipeline. In summary, Crocker will have signed agreements with Northern Border Pipeline before they cross the pipeline for construction and agreements will be in place where wind farm facilities cross the pipeline. Northern Border Pipeline has defined processes and standards that Crocker will comply with for safety and other purposes. Geronimo Energy has successfully coordinated with Northern Border on other projects over the years including another wind farm project where the pipeline passes through the project area similar to the Crocker project.
