turbine adjustment. As explained in the Affidavit, Prevailing Wind Park proposes to shift Turbine No. 8 492 feet to the west to avoid a transmission line easement.

The Confidential Addendum to Level III Intensive Archaeological Survey Report demonstrates that no cultural resources have been identified that would be affected by the proposed shifted location of Turbine No. 8.

As demonstrated in the enclosed documents, with the exception of exceeding 250 feet, the proposed turbine adjustment meets the other requirements of the Commission's Order and all other applicable regulations and requirements.
