They are quoting so called "studies" done by groups that already know what they want the answer or outcome to be prior to doing the actual study. In other words their "study" is flawed from the start. They know what they want the answer to be and work backwards from there. This is hardly something that has any real scientific evidence.

There may very well be some risks in Wind Farming. However the risks in Wind Farming are no different than any other industry and could very well be less also. I think not.
