

## Transmission Cost Recovery (TCR)



MidAmerican Energy Company, as a load-serving member of the Midcontinent Independent System Operator (MISO), is assessed costs related to regional transmission facilities that benefit customers throughout the Midwest. The South Dakota Public Utilities Commission has approved an adjustment to the TCR charge driven by regional transmission costs assessed to MidAmerican Energy. The change, effective with April 2018 bills, will increase the TCR to \$0.00105/kWh from its current charge of \$0.00058/kWh. This charge is shown as a separate line item on your bill.

Although the exact dollar amount will vary depending on a customer's type of lighting, the approximate annual percent increase for a lighting customer will be as follows:
