### **Legal Description of the Electric Service Territory Boundary between Central Electric Cooperative, Inc. and Southeastern Electric Cooperative, Inc.**

Based on a prior agreement dated the 5<sup>th</sup> day of January, 1976, signed by Intercounty Electric Association, Inc. and Turner Hutchinson Electric Cooperative, Inc.; and, on a prior agreement dated the 22<sup>nd</sup> day of September, 1975, signed by Intercounty Electric Association, Inc. and McCook Electric Cooperative, Inc., the following represents the legal description of the electric service territory boundary shared between Central Electric Cooperative, Inc. and Southeastern Electric Cooperative, Inc.

THENCE continue north to the NE corner of Section 7,

THENCE continue north to the NW corner of the SW ¼ of Section 18 of T101N, R56W, McCook County,
