Fall River Solar, LLC served Discovery Requests on Black Hills Power, Inc. on March 26, 2019. Black Hills responded on April 23, 2019, but objected to the majority of the Discovery Requests and declined to answer, produce requested documents or information, or otherwise respond to many of the Discovery Requests.

Fall River respectfully moves the Commission to

1. Consider and rule on objections made by Black Hills Power, Inc. to certain Discovery Requests propounded by Fall River and served on Black Hills on March 26, 2019; and
2. Set hearing on this motion for June 11, 2019; and
3. After considering the Black Hills objections, enter an order compelling Black Hills to fully and completely answer the questions propounded and to produce the documents and other materials requested in the Discovery Requests; and
4. Award Fall River reasonable terms and expenses for the making, preparation for, and prosecution of this motion.
