SDCL 49-41B-15 and 49-41B-16, the South Dakota Public Utilities Commission will hold a public input hearing at the above time and place on an application for approximately 10.42 miles of 345-kilovolt (KV) overhead transmission line and associated facilities (Project) located entirely within Deuel County, South Dakota. The Project is proposed by Flying Cow Wind, LLC, a wholly-owned subsidiary of Vestas Wind Systems A/S, the joint venture formed by subsidiaries of its affiliate Renewable Energy Services Inc. and Vestas Wind Systems A/S. The starting point of the Project is proposed to be located in Government Lot 2 of Section 11, Range 47W, Norden Township. The ending point will be in the NW 1/4 of Township 113N, Range 48 West, Scandinavia Township. The Project is to be completed by the third quarter of 2020.

The public input hearing will be to hear public comments regarding the Project. At the hearing, Applicant will present a brief description of the Project and the Projects. Following which interested persons may appear and present their views and comments regarding the Application. A copy of the Application is on file with the Auditor pursuant to SDCL 49-41B-15(5) and at the Commission's office and all other documents in the case, including detailed maps of the Project, will be accessible on the Commission's website at www.sdpu.com under the heading "Public Input Hearing".
