- 7. THENCE continue north to the NW corner of Section 35 of T7N, R4E,
- THENCE continue west to the SW corner of the SE<sup>1</sup>/<sub>4</sub> of the SE<sup>1</sup>/<sub>4</sub> of the SE<sup>1</sup>/<sub>4</sub> of Section 27 of T7N, R4E,
- THENCE continue north to the NW corner of the NE¼ of the NE¼ of the NE¼ of Section 27 of T7N, R4E,

- 10. THENCE continue west to the SW corner of Section 22 of T7N, R4E,
- 11. THENCE continue north to the NW corner of Section 22 of T7N, R4E,
- 12. THENCE continue west to the SW corner of the SE<sup>1</sup>/<sub>4</sub> of Section 16 of T7N, R4E.

- 1. THENCE continue north to the NW corner of the NE<sup>1</sup>/<sub>4</sub> of Section 33 of T8N, R4E, Butte County,
- 2. THENCE continue east to the NE corner of Section 35 of T8N, R4E,
- 3. THENCE continue north ending at the NW corner of the SW<sup>1</sup>/<sub>4</sub> of Section 24 of T8N, R4E.
