84 have been shifted to comply with setback requirements; Turbine 35 has been shifted to avoid wetland impacts; and Turbine 57 has been shifted to avoid potential impacts to cultural resources. As demonstrated in the enclosed documents, the shifted locations will comply with the Commission's Order and all other applicable regulations and requirements.
