In accordance with Permit Condition 22 approved by the South Dakota Public Utilities Commission (“Commission”) and included in Attachment A to its May 30, 2019 Final Decision and Order Granting Permit to Construct Facilities; Notice of Entry (“Order”) in the above-referenced docket, Deuel Harvest Wind Energy LLC (“Deuel Harvest”) submits the following documents:

proposed turbine adjustment. Deuel Harvest proposes to shift Turbine 3 691 feet to the south to ensure shadow flicker compliance.

As demonstrated by the enclosed documentation, with the exception of exceeding 250 feet, the proposed turbine adjustment meets the other requirements of the Commission's Order and all other applicable regulations and requirements.
