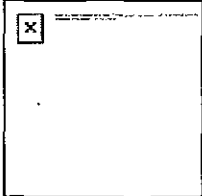

Ms. Christenson,

Staff reviewed your comments regarding ADLS file November 2, 2020 and spoke with Mr. Riniker regarding your concerns about why there is not a filing in the docket regarding an increase in the time lights in the project area are activated. As you are aware, the Commission ordered a Public Liaison Officer to work with staff to resolve concerns that arise from the project. The vast majority of these contacts are addressed informally and generally items are only filed to the docket when required by the permit, require Commission action or are unable to be resolved informally. In this instance, Crowned Ridge advised Staff of an issue with the ADLS and has been working to resolve the issue while providing updates to Staff and Mr. Riniker. Given Crowned Ridge's self-reporting and steps toward resolving the concern Staff has not found a need to make a formal filing regarding this issue.

If you have questions or concerns regarding the operation of Crowned Ridge I or Crowned Ridge II, we encourage you to contact Mr. Riniker or Staff. We remain in close contact with Crowned Ridge and we may be able to provide you with additional information and work through your concerns more efficiently than filing comments in the docket.

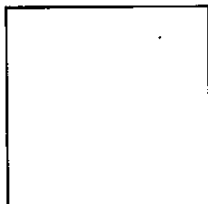

Staff has asked me to reach out to you and let you know that on October 16<sup>th</sup> Crowned Ridge self-reported an issue with the lights being activated for between 1.5 – 8 hours per night starting on October 9th. They reported to Staff that the lights were falsely being activated by migratory birds and they are working to resolve the issue through modified filtering. Crowned Ridge has been in contact with staff to let them know what they are doing to decrease the amount of false ADLS light activations.
