## **HOW THE POLL WAS CONDUCTED**

**This poll was conducted by Mason-Dixon Polling & Strategy of Jacksonville, Florida from August 22 through September 9, 2018. A total of 173 registered voters in Hyde County, South Dakota were interviewed by telephone.**

**Those interviewed were selected randomly from a telephone-matched voter registration list that included both land line and cell phone numbers**

**The margin for error, according to standards customarily used by statisticians, is no more than  $\pm 6.2$  percentage points. This means that there is a 95 percent probability that the "true" figure would fall within that range if all voters were surveyed.**

## POLL RESULTS

**QUESTION: Do you support or oppose building new wind turbines in Hyde County?**

Support	74%
Oppose	22%
Undecided	4%

**QUESTION: In 2003, the South Dakota Wind Energy Center built 27 wind turbines in Hyde County. Do you feel over the last 15 years that those wind turbines have had a positive effect or a negative effect in Hyde County?**

**QUESTION: Do you feel wind turbines are safe, or not?**

**QUESTION: Do you feel that adding the proposed new wind turbines would or would not significantly increase revenues for the county and provide increased funding for public services, such as public schools and emergency response?**
