WEEKLY REPORT ON AIRCRAFT DETECTION LIGHT SYSTEM

On May 26, 2020, in Docket Nos. EL19-003 and EL20-002 Crowned Ridge Wind, LLC (“Crowned Ridge”) committed to file weekly reports that (1) show the same information in Table 1 of the May 26, 2020 submittal for the previous week; and (2) explain what adjustments and filters were applied to the Aircraft Detection Light System (“ADLS”) in that week. This report provides the weekly table for July 12-19, 2020 and explains adjustments and filters applied in the past week.
