Dear Ms. Van Gerpen:

As required by the South Dakota Public Utilities Commission ("Commission"), this letter provides updates on the status of: (1) the operation of an aircraft detection lighting system ("ADLS") and (2) the installation of low noise trailing edge ("LNTE") blade attachments at the Crowned Ridge Wind facility.

ADLS Status

As of April 27, 2020, the ADLS for Crowned Ridge Wind is operational. See Attachment 1, Affidavit of Ronald Williams, Wind Site Manager for Crowned Ridge Wind. As required by the Settlement Agreement, Crowned Ridge Wind is in the process of depositing into the permanent school fund a check for \$170,000. When the deposit is completed, Crowned Ridge Wind will file the confirmation of the deposit with the Commission.

LNTE Status

The installation of LNTE attachments on turbine blades has commenced. Crowned Ridge Wind expects that LNTE attachments on the following currently curtailed turbines will be completed by June 15, 2020: 21, 29, 33, 37, 41, 44, 46, 48, 50, 52, 61, 63, 64, 66, and 95. Crowned Ridge Wind also expects that LNTEs will be attached on all turbines by August 15, 2020.


