1. Issuance of this permit does not preclude the requirements for obtaining necessary permits &/or approvals from other County, State or Federal Agencies and from local landowners.

2. This permit is issued subject to the revocation & appeals procedure contained in Title 50, Part 25 of the Code of Federal Regulations.

3. Permittee will acquire a right-of-way to cover the proposed overhead utility line on USFWS Easement Hand Co. 357G,1,2,3 and 356G,1. Work can be completed in the meantime using this permit. However, if permittee fails to acquire the right-of-way increase and work has been completed, they may have to return the area to its original state.

4. Permittee will complete work with a minimum of disturbance to existing vegetation (e.g., working during dry conditions as to not cause rutting from heavy equipment, etc.).

5. Bird diverters will be placed on the power lines over USFWS grassland easements to deter bird collisions with the line.

6. All old power poles will be completely removed, and any left-over construction materials will be cleaned up and removed following completion of the work.

7. Any signs or fences that are removed will be replaced.

8. Any work within the grassland easement property will be backfilled and compacted to normal contour. Any mounds of raw dirt will be smoothed out so that native plants can grow through and/or reseeded to a native plant mix.

9. Travel and access for construction of a longspan across USFWS grassland easement Hand Co. 339G. Ground disturbance will be avoided and very limited. Any ground disturbance will be restored and reseeded to its previous state.

10. This permit is for this project only; any future maintenance or repairs will require additional consultation with the Huron WMD office.

11. Permittee assumes all liability associated with this use.

12. Project work pending approval of the overhead utility line compatibility determination submitted by the Huron WMD.
