Dear Ms. Van Gerpen:

While completing title review for the Sweetland Wind Farm (“Project”), Sweetland Wind Farm, LLC (“Sweetland”), has identified three out-lots that were not previously identified on Figure A-2 of the above-referenced Application. A discussion of the three out-lots is provided below:

- The first is a parcel owned by Eric Fanning in the Southeast Quarter of Section 14, Township 111 North, Range 67 West. Sweetland has contacted Mr. Fanning and is in the process of securing a Good Neighbor Agreement covering the parcel.
- The second is a parcel owned by Jeremy and Marci Stevens in the Southeast Quarter of Section 31, Township 111 North, Range 66 West. Mr. and Mrs. Stevens are currently participants in the Project, and Sweetland is in the process of amending Mr. and Mrs. Stevens’ Wind Energy Lease and Easement Agreement to include this parcel.
- The third is a parcel owned by Travis and Beverly Letsche in the Southwest Quarter of Section 7, Township 110 North, Range 66 West. Sweetland has contacted Mr. and Mrs. Letsche and is in the process of securing a Good Neighbor agreement covering the parcel.

Each of the landowners identified above was sent notice of the Public Input Hearing scheduled for April 25, 2019.

To correct the record, enclosed is a revised Figure A-2 that is intended to replace the figure included in the Application. The revised Figure A-2 identifies the three out-lots discussed above, and shows them as "Pending Participation." Sweetland plans to address the updated Figure A-2 in supplemental testimony, as needed, but is filing the revised figure now so that it is available prior to the Public Input Hearing. Sweetland will also bring enlargements of revised Figure A-2 to the Public Input Hearing.
