Electric rates effective January 1, 2020

DSM COST ADJUSTMENT FACTOR

Effective January 1, 2020

Xcel Energy offers a variety of load management and demand side management (DSM) programs to our South Dakota customers to help them reduce their home's usage. The South Dakota Public Utilities Commission has approved a new Demand Side Management Cost Adjustment Factor as a separate line item on your monthly electric bill to recover the cost of our load management and DSM programs. Beginning January 1, 2020, the rate factor will increase from \$0.000464 per kWh to \$0.000477 per kWh.

Residential Electric Service – Winter Month Bill Example

This chart provides a comparison of customer bills by applying the prior DSM rate versus the new DSM rate. The table below shows the DSM Rider rate increase only and does not factor in any other rate change that may occur at the same time.

INFRASTRUCTURE RIDER RATE INCREASE

Effective January 1, 2020

The Infrastructure Rider Adjustment, which recovers the costs and expenses of capital projects, is increasing from \$0.006853 per kWh to \$0.008873 per kWh. The South Dakota Public Utilities Commission has approved the Infrastructure Rider Adjustment as a separate line item on your monthly electric bill beginning January 1, 2020.

TRANSMISSION COST RECOVERY RIDER RATE DECREASE

Effective January 1, 2020

Xcel Energy has upgraded transmission facilities to help ensure continued safe and reliable service to our South Dakota customers. The South Dakota Public Utilities Commission has approved a Transmission Cost Recovery (TCR) Rider as a separate line item on your monthly electric bill to recover the cost of new and modified transmission facilities. The rate factor will decrease from \$0.003037 per kWh to \$0.003027 per kWh beginning January 1, 2020.
