Southeastern Electric Cooperative, Inc. (Southeastern) has assigned territorial rights to provide electric service to the location of Section 8, T 100 N, R 52 W, of Home Township in Turner County, SD at location 45935 268th Street, Chancellor, S.D.

Under the conditions of this agreement, Southeastern does hereby consent that Sioux Valley-Southwestern Electric Cooperative, Inc. (dba Sioux Valley Energy) may extend its facilities into the above described service area of Southeastern to provide electric service for a proposed residential/farm service in Section 8.

This release is specifically limited to the proposed residential/farm service and is for the life of said service. Exhibit "A" provides the request of the owner of this land to have Sioux Valley Energy serve this residential/farm service in Section 8 described above and a township map of the general location of said service.

This consent is not to be construed as having any impact upon or indicating a desire to change the service areas assigned by the South Dakota Public Utilities Commission. This agreement becomes effective upon its approval by the South Dakota Public Utilities Commission.

The foregoing is hereby agreed to on this 3rd day of May 2019.

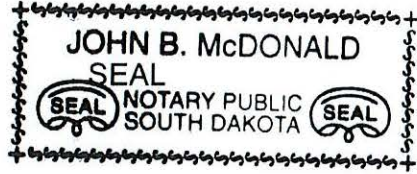
