**STIPULATION FOR

Staff of the South Dakota Public Utilities Commission (Commission) and Tatanka Ridge Wind, LLC (Applicant) hereby file this Stipulation for Procedural Schedule.

The parties to this proceeding are currently Staff and Applicant (jointly the Parties). To date, no individuals have filed an application for party status in this docket, however should any person request party status, Staff will communicate this proposed schedule with each requestor.

Under SDCL 49-41B-25, the Commission must issue a decision on this matter within six months of the filing. The Parties recommend the following procedural schedule:


In addition, the Parties agree that all responses to discovery requests are due 10 business days after service, unless otherwise agreed to, in writing, by the inquiring and responding parties.
