## NOTICE OF FILING OF AFFIDAVIT OF STEVEN GREBER, AND MOTION FOR EXAMINATION OR ADMISSION UPON STIPULATION OF COUNSEL

Under the Commission's Order for and Notice of Evidentiary Hearing, dated October 1, 2019, and the prior Order Granting Motion Establishing Procedural Schedule, etc., dated September 20, 2019, Intervenor Steven Greber, together with Mary Greber, hereby give notice of herewith submitting the Affidavit of Steven Greber (hereafter "Greber Affidavit," dated and signed November 13, 2019), such being intended to state and reflect their respective interests in this matter.

Intervenors further given notice they will not be available for examination by Applicant or others during the course of the hearing February 4-7, 2020, for reasons stated on p. 1 of the Greber Affidavit, lines 6 through 20. As counsel, I was further advised by email on November 15, 2019 that Greber presently expects his pending departure will take place "Thanksgiving Holiday weekend," and the "latest will be the following week," while he expects to return to the United States in the "April-May time frame." Mr. & Mrs. Greber are departing for Florida today (November 17), but the undersigned is confident that with the Commission's consent and arrangements for a reporter, counsel for interested parties can examine Mr. Greber, upon the Greber Affidavit, by means of telphone, provided this is done during this short time frame.
