Apologies for the delay. As requested, please see below information regarding the Crowned Ridge II project in Deuel County:

Due to MISO interconnection risks, Crowned Ridge Wind II is deferring the construction for 100 MWs of the planned 300 MW project. Specifically, the project will proceed as a 200 MW wind project until the MISO system supports a cost-effective interconnection for the last 100 MWs. Our team plans to inform landowners affected by the project size reduction at meetings that will take place on October 9 and 10.

Crowned Ridge Wind II is currently pending approval at the South Dakota Public Utilities Commission (PUC). On September 20, 2019, Crowned Ridge Wind II notified the South Dakota PUC of its plan to review the upcoming Q1 2020 MISO and SPP interconnection study and costs to determine whether to construct 100 MWs in 2020 or extend the time to begin construction. Crowned Ridge Wind II intends to construct 200 MWs, as the first 200 MWs have no interconnection concerns, provided it obtains a facilities permit from the South Dakota PUC.

It is our intent to build the additional 100 MWs for Crowned Ridge Wind II when the MISO system supports cost-effective interconnection to the transmission grid. If, at some point in the future, those costs are sufficiently reduced so that the project makes economic sense for our company, its participating landowners and customer, we will build the remainder of the project.

Our team will have additional information on the viability of the last 100 MWs in Q1 2020 when additional studies on the transmission are completed.

The attached maps help depict the 200 MW project we are currently proceeding with along with the 100 MWs that are currently deferred until further notice.




