**REQUEST FOR WITHDRAWAL**

Black Hills Power, Inc. d/b/a Black Hills Energy (“Black Hills Power”) hereby submits to the South Dakota Public Utilities (the “Commission”) this Request for Withdrawal in the above-captioned matter.

In support of this Request, Black Hills Power sets forth the following:

1. On December 31, 2019, Black Hills Power and the South Dakota Public Utilities Commission Staff entered into a Second Amendment to Settlement Stipulation in Docket Nos. EL17-006 and EL17-008 (the “Stipulation”). As part of the Stipulation, Black Hills Power agreed that upon receiving Commission approval of the Stipulation it would file a notice withdrawing its petition in the above-captioned docket, without prejudice.

2. On January 7, 2020 at its regularly scheduled meeting, the Commission voted unanimously to approve the Stipulation.

3. The Commission confirmed its approval of the Stipulation by order dated January 10, 2020.

WHEREFORE, Black Hills Power respectfully requests the Commission enter an order, or take any other steps necessary, to effectuate the withdrawal of the pending petition, without prejudice.


