

EXCEPTION TO ELECTRIC SERVICE ON ASSIGNED AREAS

Southeastern Electric Cooperative, Inc. (Southeastern) has assigned territorial rights to provide electric service to the location of Southwest corner of Section 19, T 100 N, R 61 W, of Starr Township in Hutchinson County, SD at location 40432 271st Street, Dimock, South Dakota 57331

Under the conditions of this agreement, Southeastern does hereby consent that Douglas Electric Cooperative, Inc., (Douglas Electric) may extend its facilities into the above described service area of Southeastern to provide electric service for a proposed hog facility service in Section 19 by Mr. Myles Bialas, 301 South Ben Street Parkston, South Dakota 57366.

This release is specifically limited to the proposed hog facility service and is for the life of said service. **Exhibit "A"** provides the request of the owner of this land to have Douglas Electric serve this hog facility service in Section 19 described above and a township map of the general location of said service.

Exhibit "B" shows the location of Southeastern's nearest electrical line facilities and those of Douglas Electric's. For Southeastern to extend electrical line facilities to provide service to this hog facility it would require electric distribution line construction of 3,550 feet and would require an aid to construction cost of \$7,800 for this service. With Douglas Electric's distribution line facilities just 1,112 feet down the road the members cost is only \$571.43.

This consent is not to be construed as having any impact upon or indicating a desire to change the service areas assigned by the South Dakota Public Utilities Commission. This agreement becomes effective upon its approval by the South Dakota Public Utilities Commission.

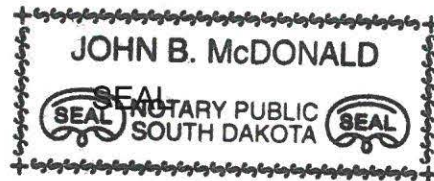
