Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act<sup>1</sup> and Section 35.13 of the regulations of the Federal Energy Regulatory Commission (“Commission”),<sup>2</sup> MidAmerican Energy Company (“MidAmerican”) respectfully submits a Certificate of Concurrence and a concurrence tariff record for MidAmerican’s eTariff database to reflect its incorporation by reference of the “Fourth Amendment to and Restatement of Facilities and Operating Agreement Ottumwa Generating Station Unit 1 Electric Transmission and Substation Facilities” (“Agreement”), which was filed by ITC Midwest LLC (“ITC”) and designated as Rate Schedule No. 113.

## **I. Description of filing**

On June 17, 2019 in Docket No. ER19-2173, ITC submitted for filing the Agreement (“June 17, 2019 Filing”) on behalf of itself, MidAmerican, and Interstate Power and Light Company (“IPL”). The Commission received the Agreement in a Combined Notice of Filings #1 on June 18, 2019.<sup>3</sup>

MidAmerican is submitting a concurrence tariff record (Rate Schedule No. 135) to incorporate the Agreement into MidAmerican’s eTariff database and a Certificate of Concurrence with respect to the rate schedule.
