Notice of Cancellation of South Dakota OATT (Tariff ID 39)

Dear Secretary Bose:

Pursuant to Section 205 of the Federal Power Act¹ and Section 35.15 of the Federal Energy Regulatory Commission's Regulations,² NorthWestern Corporation d/b/a NorthWestern Energy submits a Notice of Cancellation to cancel NorthWestern's South Dakota Open Access Transmission Tariff (OATT),³ including all schedules and attachments. Cancellation is appropriate under Section 35.28(c)(1)(iv) of the Commission's regulations⁴ because service over NorthWestern's transmission facilities is provided under the Southwest Power Pool, Inc.'s (SPP) OATT.

NorthWestern respectfully requests an effective date of July 16, 2019, for this cancellation.

I. Background

A. NorthWestern Energy

NorthWestern is a public utility engaged in the generation, transmission, and distribution of electricity and the supply and transportation of natural gas. Its facilities are located primarily in Montana and South Dakota. In South Dakota, NorthWestern is a transmission-owning member of SPP and has transferred functional control of its electric transmission facilities to SPP. As a

member of SPP, NorthWestern is also a transmission customer under the SPP OATT and participates in the regional day-ahead and real-time energy and ancillary services markets administered by SPP, known as the SPP Integrated Marketplace.

NorthWestern also maintains a separate OATT in Montana where it is a transmission owner/operator and Balancing Authority Area operator within the Western Electricity Coordinating Council. NorthWestern's Montana and South Dakota transmission facilities are not physically connected and are not in the same electric reliability region. This filing cancels NorthWestern's South Dakota OATT and does not affect Montana.

B. Service under the South Dakota OATT

NorthWestern joined SPP, a Commission-approved Regional Transmission Organization (RTO),⁵ and transferred functional control of its electric transmission facilities to SPP on October 1, 2015.⁶ Immediately prior to integration with SPP, NorthWestern had eleven customers with transmission service agreements (TSAs) under its South Dakota OATT. Those TSAs have been canceled,⁷ and the customers now either take transmission service under the SPP OATT, take distribution service under a state tariff, or take wholesale distribution service under Schedule 10 of the SPP OATT. In addition, the last remaining generator interconnection agreement (GIA) under the South Dakota OATT has been transferred to a three-party GIA under the SPP OATT, and NorthWestern has filed a notice of cancellation for the GIA under the South Dakota OATT.⁸ Thus, there are no longer any eligible customers taking service under the South Dakota OATT.

II. Description of Filing

Because NorthWestern transferred function control of its transmission facilities to SPP and no longer serves any customers under its South Dakota OATT, NorthWestern respectfully requests that the Commission accept this notice of cancellation, effective July 16, 2019. This cancellation is appropriate because SPP now provides all open access transmission services over

NorthWestern's South Dakota transmission system under the SPP OATT.⁹ Cancellation of NorthWestern's South Dakota OATT is also consistent with the Commission's actions on cancellations filed by other transmission owners who are members of a Commission-approved ISO or RTO.¹⁰

III. General Information

Pursuant to the Commission's regulations, NorthWestern provides the following information:

NorthWestern Energy requests an effective date of July 16, 2019.

C. Notice

NorthWestern does not have any customers under the South Dakota OATT. NorthWestern will provide a copy of this filing to the South Dakota Public Utilities Commission. Copies are also available for public inspection at NorthWestern's Corporate Office, 3010 West 69th Street, Sioux Falls, South Dakota.

NorthWestern respectfully submits that any requirements of 18 C.F.R. § 35.15 that have not been specifically addressed are inapplicable to this filing. To the extent that the Commission determines the requirements of Section 35.15 or any other rules to be applicable, NorthWestern Energy respectfully requests waiver of the requirements of such provisions.
