1. Beginning at the NE corner of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 29 of Township 1 South (T1S), Range 5 East (R5E), Pennington County,
2. Thence continue east to the east boundary of Government Lot 9 of Section 28 of T1S, R5E,
3. Thence continue south to the intersecting point with the southern boundary of Lot 1, Block 1 of the Harney Mountain Wilderness Estates,
4. Thence continue southwest to the southernmost point of Lot 1, Block 1 of the Harney Mountain Wilderness Estates,
5. Thence continue southwest to the east corner of Lot 8, Block 1 of the Harney Mountain Wilderness Estates,
6. Thence continue southwest and west following the southern boundary of Lot 8, Block 1 of the Harney Mountain Wilderness Estates to the SE corner of LOT ALL of February #1 Lode MS 666 in Section 33 of T1S, R5E,

2. Thence continue northeast to the west corner of Lot C-14 of Wolframite Estates in Section 34 of T1S, R5E,
3. Thence continue southeast to the south corner of Lot C-14 of Wolframite Estates in Section 34 of T1S, R5E,
4. Thence continue northeast to the north corner of Lot C-13 of Wolframite Estates in Section 34 of T1S, R5E,

5. Thence continue southeast to the east corner of Lot C-13 of Wolframite Estates in Section 34 of T1S, R5E,
6. Thence continue southwest to the north corner of Lot C-6 Less the Portion 1.95AC of Wolframite Estates in Section 34 of T1S, R5E,
7. Thence continue southeast following the east lot lines of Lot C-6 Less the Portion 1.95AC and Lot C-1R to the easternmost point of Lot C1-R of Wolframite Estates in Section 34 of T1S, R5E,
