## Addendum to the Service Territory Boundary Agreement between Black Hills Electric Cooperative, Inc. and Black Hills Power, Inc. dba Black Hills Energy

This is an Addendum ("Addendum") to the Service Territory Boundary Agreement between Black Hills Electric Cooperative, Inc. ("BHEC"), of PO Box 792, Custer, SD 57730-0112, and Black Hills Power, Inc. dba Black Hills Energy ("BHP"), of 7001 Mount Rushmore Road, SD 57702; jointly referred to as the Parties.

# **GENERAL PROVISIONS**

This Addendum shall affect no portions of the territorial designation but that portion specifically identified herein, all other portions of the Agreement shall remain in full effect as established under the Agreement, or as changed through any subsequent modification performed according to the laws of South Dakota.

This Addendum shall be filed with, and is subject to the approval of, the SD PUC and if such approval is granted, shall be retained by the Parties and the SD PUC as evidence of territorial designation.

This Addendum shall be binding upon the Parties and their successors, assigns, agents and representatives.

Approval of this Addendum by the Commission shall not in any way constitute a determination by the Commission as to the merits of any allegations or contentions that may arise as a result of this Addendum or the Agreement, and shall not foreclose the Commission from reviewing any allegations or contentions that may arise hereafter.

This Addendum shall not foreclose the ability of the Parties hereto, to modify the service territory designations of this Addendum, through the processes identified under the laws of the State of South Dakota.
