

INFRASTRUCTURE RIDER RATE INCREASE

Effective January 1, 2021

The Infrastructure Rider Adjustment, which recovers the costs and expenses of capital projects, is increasing from \$0.008873 per kWh to \$0.011897 per kWh. The South Dakota Public Utilities Commission has approved the Infrastructure Rider Adjustment as a separate line item on your monthly electric bill beginning January 1, 2021.

TRANSMISSION COST RECOVERY RIDER RATE INCREASE

Effective January 1, 2021

Xcel Energy has upgraded transmission facilities to help ensure continued safe and reliable service to our South Dakota customers. The South Dakota Public Utilities Commission has approved a Transmission Cost Recovery (TCR) Rider as a separate line item on your monthly electric bill to recover the cost of new and modified transmission facilities. The TCR rate will increase from \$0.003027 per kWh to \$0.003446 per kWh beginning January 1, 2021.
