On the image below, you will see my power production for yesterday(April 28th)..., usage and the left-over amount that is sold to Black Hills Electric Cooperative. The top red line is total generated from my panels. The orange line the amount of power used in my house. The difference is what I send to the power company for 2.3 cents a kwh hour. They in turn sell it to you at 6.9 cents. The difference is their profit. Now they want me to sell them all my power at 2.3 cents and I must then buy it back to 6.9 cents....all of it... if BHE has their way. I am sure BHEC will jump on the bandwagon if they get the chance. If you go below the middle straight line, you will see the blue line, that represents the total I sell BHEC. The Green Line below is the power I put into my batteries. The blue line above the line is the amount I purchase from the power company. The green line above is the amount I draw down from the batteries. If the power company has it's way, the blue line above will match total power production instead of the 4 hours I am currently purchasing. Hope this makes sense. In the summer time, I purchase zero power from the power company, or about 5 to 6, sometimes 7 months of the year I purchase no electricity, only sell it to them at a cheap rate. On an annual basis, I produce enough electricity to power two other average sized homes. The winter time, not so much!! See how I am helping to reduce the CO2 emissions!! If most of us did this, think of the savings to the atmosphere!!! This is what the power companies fear!! They don't care about the environment!! They only care about GREED!!!

If the power company wanted to be better citizens, they would support those of us that are trying to do the right thing for the environment and the world. They could jump in and make leasing arrangements with people who want to help the world and control their own energy footprint. That would be a money making enterprise for them and could cut down the need for expensive fossil generation production. They could also convert their coal and gas production sites to solar and wind sites. It is cost effective to do so...but they want to punish us for wanting to be good citizens to the world and the environment. With the new stimulus/jobs bill that President Biden is trying to push forward, that would possibly help for them to convert. Instead of punishing us, they need to use their corporate influence to help us and themselves. It would be an exceptionally good business practice. The economics are there.
