COMES NOW, Staff of the South Dakota Public Utilities Commission (Staff), North Bend Wind Project, LLC (North Bend), and Judi Bollweg, individually and on behalf of Tumbleweed Lodge and Bollweg Family LLLP, and Michael Bollweg, individually and on behalf of Bollweg Family, LLLP (Intervenors) and hereby file this Joint Stipulation and Motion to Adopt Second Revised Procedural Schedule.

This docket was opened on June 23, 2021, with the filing by North Bend Wind Project, LLC for a permit of a wind energy facility in Hyde County and Hughes County, South Dakota. The parties to this proceeding are North Bend Wind, LLC, Staff, Judi Bollweg, individually and on behalf of Tumbleweed Lodge and Bollweg Family LLLP, and Michael Bollweg, individually and on behalf of Bollweg Family, LLLP.

Under SDCL 49-41B-25, the Commission is required to make a decision on this matter within nine months of receiving the filing, unless the Applicant requests an extension pursuant to SDCL 49-41B-24.1. On November 1, 2021, the Commission issued an Order Granting Motion for Procedural Schedule. On November 16, 2021, North Bend filed a Motion to Extend Deadline and requested the Commission suspend the procedural schedule. On February 25, 2022, North Bend filed a new Motion to Extend Deadline. On March 8, 2022, the Commission granted this Motion and extended the deadline indefinitely. On August 17, 2022, North Bend filed a Letter regarding Motion for Scheduling Order.

Since this filing, Staff, North Bend and the Intervenors engaged in discussions and stipulate to and request the Commission adopt the following revised procedural schedule:


