Monthly Construction Report

2023 Monthly Construction Activities 10/2023

For the Month of October 2023, Wanzek Construction, Inc. has progressed their activities as follows:

- Civil is continuing with road reclaim activities through the month of October and will start to build punch lists
 on access roads in preparation for Access Road Completion Certificates in November. In October, installation
 reclamation has achieved 66% completion, and 71% of access roads completed with topsoil pushed back.
 Approximately 50% completion of beauty rings/spur roads on site and has 2 out 12 intersection modifications
 reclaimed.
- Underground collection install is 96% complete at the end of October with one junction box left to install in November. Termination crews completed 7 out of 21 junction box terminations and 20 out of 42 splice terminations. Box pad installations are completed and 20% of PMT installations remain to be completed in November. Fiber termination crews have completed 34% of tower terminations. Substation and field splices will be completed in the month of November.
- Substation crews plan to energize substation early November. Steel and equipment setting over 90% complete by the end of October, as well as pulling cable into the control house. Substation walkdown is planned prior to energization activities.
- Offload is completed in the month of October. All turbines are installed by first week of November. Tower
 wiring crews are almost complete with 7 towers remaining. Mechanical completion crews are at 72% of towers
 completed, 69% walkdowns completed and 45% of Mechanical Completion Certificates received by the end of
 October.
- Energization to the T-line took place 11/9/23; Substation energized 11/14/23
