filed on September 9, 2021, with a September 30, 2021, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective September 30, 2021. It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariffs is hereby granted and the revisions are approved, effective for services rendered on and after September 30, 2021.
