

### JOINT SERVICE RIGHTS EXCEPTION AGREEMENT BETWEEN

## NORTHERN ELECTRIC COOPERATIVE, INC. and DAKOTA VALLEY ELECTRIC COOPERATIVE, INC.

This Service Rights Exception Agreement ("Agreement") is made and entered into effective as of the dates which appear on the signature pages, by and between Northern Electric Cooperative, Inc. of Bath, South Dakota ("Northern") and Dakota Valley Electric Cooperative, Inc. of Edgeley, North Dakota ("Dakota").

#### RECITALS

(A) Northern Electric has been granted exclusive rights to serve an area in Brown County, South Dakota described as:

The North Half (N <sup>1</sup>/<sub>2</sub>) of Section One (1), Township One Hundred Twenty-eight North (128N), Range Sixty-one West (61W), Brown County, South Dakota. See attached map marked as Exhibit B.

GPS Coordinates: 45.93570, -98.113362

(B) Dakota Valley by this Agreement is hereby granted a service rights exception to the above-described location, (if approved by the Public Utilities of the State of South Dakota) to extend single-phase service to this location and to provide electrical service to an irrigation pivot and pumps located thereon.

In order for Northern to extend electrical service to this location from its most proximate facilities would require construction of approximately ten thousand three-hundred seventy (10,370) feet of line at a cost of \$103,666 of which \$62,220 is to be charged the Partnership under Northern's aid to construction policy.

See map attached as Exhibit B.

(C) Dakota has facilities within one thousand six-hundred sixty-three (1663) feet of the service location. Under Dakota's line construction policies, they do not charge the consumer for the first 2000 feet of line construction. Under Dakota's policy the Partnership would not be required to make any payment in aid of construction costs. See map attached as Exhibit B.

Based upon the foregoing recitations, the parties **NOW THEREFORE AGREE AS** FOLLOWS: 1. <u>Scope of Agreement.</u> The scope of this Agreement is limited to the following transaction:

Dakota Valley Electric Cooperative will be permitted to construct single-phase services to the irrigation pivot and pumps at the location described at:

The North Half (N <sup>1</sup>/<sub>2</sub>) of Section One (1), Township One Hundred Twenty-eight North (128N), Range Sixty-one West (61W), Brown County, South Dakota. See attached map marked as Exhibit B.

GPS Coordinates: 45.93570, -98.113362

From and after approval of this Agreement by the Public Utilities Commission, Dakota Valley Electric Cooperative will be granted the right to serve the above-described location and facility located thereon.

- 2. <u>Compensation.</u> The Parties agree that no monetary compensation is owed to Northern Electric for this service rights exception agreement.
- 3. <u>Lost Revenue.</u> The Parties agree that no additional compensation will be owed by Dakota Valley Electric Cooperative to Northern Electric Cooperative in the future for lost revenue related to the transaction described herein.
- 4. <u>Reservation of Rights.</u> Except specifically set forth herein, this Agreement does not modify or limit the legal rights of any Party.
- 5. <u>No Precedent.</u> The Parties recognize that this Agreement is the result of negotiations between the Parties and that this Agreement, and the South Dakota Public Utilities Commission's ("Commission") approval of this Agreement, does not represent any binding or legal precedent on any party in any other matter.
- 6. <u>Request for Commission Approval of the Agreement.</u> Coinciding with execution of this Agreement by all Parties, Northern Electric has prepared and filed a Joint Filing to the Commission by the Parties to approve this Agreement.
- 7. Miscellaneous.

a. <u>Entire Agreement and Modification.</u> The Agreement contains the entire agreement and understandings of the Parties hereto regarding the scope of the Agreement and appropriate compensation for the

transactions described herein. All previous communications, or agreements, between the parties hereto, either verbal or written, with reference to the subject matter of this Agreement are hereby abrogated. No amendment, modification of waiver of, or consent with respect to any provision of this Agreement shall be effective unless the same shall be in writing and signed by duly appointed representatives of all Parties, and then any such amendment modification, waiver or consent shall be effective only in the specific instance and for the specific purpose for which given.

- b. <u>Assignment.</u> None of the Parties shall assign, or sublet, this Agreement, voluntarily, involuntarily or by operation of law, without the prior written consent of the other.
- c. <u>Severability.</u> If any provision of this Agreement shall be found invalid or unenforceable, in whole or in part, by a court of competent jurisdiction or the Commission, then such provision shall be deemed to be modified or restricted to the extent and in a manner necessary to render the same valid and enforceable, or if that is not possible, such provision shall be stricken an deleted form this Agreement, as the case may require, and extent permitted by law and with the purpose to achieve the fundamental intent of the parties.
- d. <u>Choice of Laws.</u> This Agreement shall be construed and interpreted in accordance with the laws of the State of South Dakota and excluding any choice of law or rules that may direct the application of laws or another jurisdiction.
- e. <u>Agreement Drafted Jointly.</u> The Parties agree that none of the Parties shall be deemed solely responsible for drafting all or any portion of this Agreement, and in the event of a dispute, responsibilities for any ambiguities arising from any provision of this Agreement shall be shared equally among the Parties.
- f. <u>Regulation.</u> The Parties acknowledge that this Agreement is subject to the jurisdiction of the Commission.
- g. <u>Effective Date.</u> The effective date of this Agreement is the date upon which the Agreement has been approved by the Commission.
- h. <u>Notice.</u> Any notice permitted or required by this Agreement shall be made in writing and personally served or mailed (postage prepaid, return receipt requested) and shall be effective upon the date of

personal service, or if by mail, upon the date of receipt.
