



TRANSMISSION COST RECOVERY RIDER RATE CHANGE

Effective January 1, 2022

Xcel Energy has upgraded transmission facilities to help ensure continued safe and reliable service to our South Dakota customers. The South Dakota Public Utilities Commission has approved a Transmission Cost Recovery (TCR) Rider as a separate line item on your monthly electric bill to recover the cost of new and modified transmission facilities. The TCR rate will decrease from \$0.003446 per kWh to \$0.003245 per kWh beginning January 1, 2022.

Residential Electric Service

The chart below shows the change to customer bills from the TCR rate decrease. The comparison does not reflect any other rate changes that may occur at the same time.

INFRASTRUCTURE RIDER RATE CHANGE

Effective January 1, 2022

The Infrastructure Rider Adjustment, which recovers the costs and expenses of capital projects, is increasing from \$0.011897 per kWh to \$0.013361 per kWh. The South Dakota Public Utilities Commission has approved the Infrastructure Rider Adjustment as a separate line item on your monthly electric bill beginning January 1, 2022.
