On October 27, 2021, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) filed for approval of revisions to its Rate SAL – Street and Area Lighting Tariff. With this filing, MidAmerican proposes new rates for light emitting diode (LED) lighting options and several other changes. MidAmerican proposed an effective date of December 1, 2021.

On October 28, 2021, the Commission electronically transmitted notice of the filing and the intervention deadline of November 12, 2021, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on November 23, 2021, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a December 1, 2021, effective date. Finding the revisions to be just and reasonable,

the Commission voted unanimously to approve the revisions, effective December 1, 2021.


It is therefore


