On January 28, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from Otter Tail Power Company (Otter Tail) for approval of tariff revisions to its Small Power Producer Riders, Sections 12.01, 12.02, and 12.03. Otter Tail proposes to update the energy payments as well as the wind renewable energy credits. These payments are made to small qualifying facilities within the Otter Tail service area. Otter Tail also proposes to offer an Optional Production Meter to customers who wish to track their generation. Otter Tail requests an effective date of April 1, 2022.

On February 3, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of February 18, 2022, to interested entities and persons on the Commission's PUC Weekly Filings electronic listsery. No petitions to intervene or comments were filed. On March 17, 2022, Otter Tail filed responses to data requests and updated tariff sheets. On March 24, 2022, Commission staff filed a Memorandum.

The Commission has jurisdiction over this matter pursuant to 16 U.S.C Chapter 12 § 824a-3, 18 C.F.R Part 292, SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on March 29, 2022, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with an April 1, 2022, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective April 1, 2022. It is therefore

ORDERED, that Otter Tail's request to revise its aforementioned tariff sheets is hereby granted, and the revisions are approved, effective for services rendered on and after April 1, 2022.
