On February 15, 2022, the South Dakota Public Utilities Commission (Commission) received MidAmerican Energy Company's (MidAmerican) filing for approval of tariff revisions regarding its Transmission Cost Recovery (TCR) 2021 Reconciliation and 2022 New Factor Calculation. MidAmerican's TCR mechanism was established in the company's most recent rate case, EL14-072. With this filing, MidAmerican is establishing new TCR rates based on true ups to the actual over/under recovery from 2021, 2022 forecasted MISO transmission expense, and the forecast over/under recovery for January through March of 2022. MidAmerican requests the new TCR factors have an effective date of April 1, 2022.

On February 17, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of March 4, 2022, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The revised tariff sheet, effective for service rendered on or after April 1, 2022, is as follows:

SDCL 49-1A-8 authorizes the Commission to require a deposit of up to \$50,000 in the Commission's Regulatory Assessment Fee Fund to defray Commission expenses incident to analyzing and ruling upon this type of filing.

The Commission has jurisdiction over this matter pursuant to SDCL Chapters 49-1A and 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 4934A-12, and 49-34A-25.1 through SDCL 49-34A-25.4, and ARSD 20:10:13.

At its regularly scheduled meeting on March 15, 2022, the Commission considered this matter. Commission staff requested the Commission assess a filing fee up to the statutory limit to account for actual expenses incurred in review of this filing commencing from the filing date. Commission staff also recommended approval of the revised TCR rate factors and revised tariff sheet with an effective date of April 1, 2022. The Commission voted unanimously to assess a filing fee as requested by Commission staff up to the statutory limit of \$50,000 to account for actual expenses incurred in review of this filing commencing from the filing date. Having thoroughly reviewed the filings in the docket, the Commission found the TCR rates and tariff

revisions to be just and reasonable. The Commission voted unanimously to approve the revised TCR rate factors and revised tariff sheet with an effective date of April 1, 2022. It is therefore

ORDERED, that MidAmerican Energy Company shall be assessed a filing fee pursuant to SDCL 49-1A-8 for actual expenses incurred by the Commission commencing from the filing date not to exceed \$50,000. It is further

ORDERED, that the revised TCR rate factors and revised tariff sheet set forth above are approved effective April 1, 2022.
