ORDER APPROVING
TARIFF REVISIONS

EL22-004

On February 18, 2022, the South Dakota Public Utilities Commission (Commission) received a filing from MidAmerican Energy Company (MidAmerican) for approval of revisions to its Rate SAL – Street and Area Lighting Tariff. MidAmerican proposes to add new rates for customer-owned light emitting diode (LED) lighting at higher wattages than are currently in the tariff. The proposed rates were calculated using the same methodology as approved in Docket EL21-030. MidAmerican requests an effective date of March 22, 2022.

The revised tariff sheet is as follows:

On February 24, 2022, the Commission electronically transmitted notice of the filing and the intervention deadline of March 11, 2022, to interested entities and persons on the Commission's PUC Weekly Filings electronic listserv. No petitions to intervene or comments were filed.

The Commission has jurisdiction over this matter pursuant to SDCL Chapter 49-34A, specifically 49-34A-4, 49-34A-6, 49-34A-8, 49-34A-10, 49-34A-12, 49-34A-93, and ARSD 20:10:13:02 through 20:10:13:28.

At its regularly scheduled meeting on March 15, 2022, the Commission considered this matter. Commission staff recommended approval of the tariff revisions with a March 22, 2022, effective date. Finding the revisions to be just and reasonable, the Commission voted unanimously to approve the revisions, effective March 22, 2022. It is therefore

ORDERED, that MidAmerican's request to revise its aforementioned tariff page is hereby granted and the revisions are approved, effective for services rendered on and after March 22, 2022.
